## **GOVERNMENT TRAVEL MANDATE-EFFECTIVE AUGUST, 1 2020**

All travelers entering Massachusetts, both out of state residents and Massachusetts residents returning home, must comply with a new travel order. Travelers must now fill out a *Massachusetts Traveler Form* at https://www.mass.gov/forms/massachusetts-travel-form unless they are coming from a state that has been designated a lower risk COVID-19 state or fall into an exemption category. Travelers arriving from a high-risk state must quarantine for 14 days unless they can produce a negative COVID-19 test result administered on a sample taken not more than 72 hours prior to arriving in Massachusetts.


